22/31 Local Highways Panel Road Survey Results

The Clerk shared with those present the results of two recent speed surveys carried out by Essex Highways.

Mill Road/Church Street

Survey conducted late last year. Average daily speed of vehicles travelling eastbound was 30.4mph with an average daily volume of 1,566 vehicles. The average speed of vehicles travelling westbound was 27.2mph with an average daily volume of 1,029 vehicles.

As the speed surveys do not evidence a speeding issue at a level where traffic calming actions would be considered, Essex Highways will not progress this any further.

Southend Road junction with Coxes Farm Road

Survey conducted late last year. Average daily speed of vehicles travelling northbound was 21.8mph with an average daily volume of 5,299 vehicles. The average daily speed of vehicles travelling southbound was 24.5mph with an average daily volume of 4,667 vehicles. The speed surveys do not evidence a speeding issue at a level where traffic calming would be considered, Essex Highways will not progress this any further.

It was discussed that it would be interesting to know the date and time the surveys were carried out and the Clerk was requested to find out this information.

Basildon Borough Council environment committee are planning to plant a circle of trees near Allington Court. The Clerk was asked to find out the exact location.

Approval for the Village Council and South Green Women's Institute to plant two tree on the Village Green has been granted. Cllrs therefore began discussing which species of tree should be chosen.
